Conversion to the International Central Securities Depository Model of Settlement

We can confirm that all 50 sub-funds of SSGA SPDR ETFs Europe I Plc successfully converted to the International Central Securities Depository (“ICSD”) settlement model on the close of business **Friday, 9th March 2018**, the Effective Date for the Scheme. As from **Monday, 12th March 2018** all holdings are reflected under the ICSD issuance structure and all settlement activity will be processed via the ICSD model.
