CHANGES TO THE PROSPECTUS AND SUPPLEMENTS

Dear Shareholder,

SSGA SPDR ETFs Europe I plc (the "Company")

We are writing to you as a Shareholder of the Company to advise of the following changes to the Prospectus which will take effect on 19 February 2026 (the "Effective Date") or such later date as the Prospectus is noted by the Central Bank of Ireland.

1. Changes to Fund Names

As part of a rebranding exercise carried out by the Investment Manager, the names of certain sub-funds will change as set out in appendix 1.

2. Prospectus Addendum

The contents of the Addendum to the Prospectus dated 10 October 2025 has been incorporated into the main Prospectus.

3. Additional Risk Disclosures

The updated prospectus includes additional risk disclosures in respect of:

- Risk of settlement time misalignment.
- An update of the tax risk disclosure in respect of Indian and Brazilian Capital Gains Tax.

4. ESG Investing

The ESG investing section of the prospectus has been updated to include a section describing ESG Integration in investment processes.

5. Other updates

Further updates are being made to the following sections of the Prospectus:

- Directory/Management.
- Index Tracking Funds, to add synthetic replication language.

(ii) With the introduction of hedged Share Classes, the following sections of the Fund Supplement have been updated:

- The Permitted Investments section of the Fund Supplement has been updated to reflect that FDIs may be used for currency hedging purposes as well as for efficient portfolio management purposes.
- As hedged Share Classes are being reflected within the Fund Supplement, details regarding currency hedging have been included in the Investment Policy.
- Additional investment risks are being included in the Supplement relating to Share Class Risk and Currency Hedging Risk as indicated below. The Derivatives Risk section is also being updated to reflect the use of FDIs for currency hedging purposes as well as efficient portfolio management purposes.

“Share Class Risk: There is no segregation of liabilities between Classes of the Fund. While the Investment Manager and/or Sub-Investment Manager will seek to ensure that gains/losses on and the costs of the relevant FDI associated with any currency hedging strategy will accrue solely to the Class for which it is intended, the transactions could result in liabilities for other Classes.”

“Currency Hedging Risk: Hedges are sometimes subject to imperfect matching between the hedging transaction and the risk sought to be hedged. There can be no assurance that the Fund’s hedging transactions will be effective. As the purpose of currency hedging is to try to reduce or eliminate losses caused by exchange rate fluctuations, it can also reduce or eliminate gains where the currency in which the Fund’s assets are denominated appreciates.”
