CHANGES TO THE PROSPECTUS

Dear Shareholder,

SSGA SPDR ETFs Europe II plc (the “Company”)

We are writing to you as a Shareholder of the Company to advise of the following changes to the Prospectus which will take effect on 19 February 2026 (the “**Effective Date**”) or such later date as the Prospectus is noted by the Central Bank of Ireland.

1. Changes to Fund Names

As part of a rebranding exercise carried out by the Investment Manager, the names of certain sub-funds will change as set out in appendix 1.

2. Prospectus Addendum

The contents of the Addendum to the Prospectus dated 10 October 2025 has been incorporated into the main Prospectus.

3. Investor Voting Choice

The Proxy Voting & Asset Stewardship section of the prospectus has been updated to include details in respect of Investor Voting Choice that will be made available to investors of the Company.

4. Additional Risk Disclosures

The updated prospectus includes additional risk disclosures in respect of:

- Risk of settlement time misalignment
- An update of the tax risk disclosure in respect of Indian and Brazilian Capital Gains Tax

5. ESG Investing

The ESG investing section of the prospectus has been updated to include a section describing ESG Integration in investment processes.

6. Other updates

Further updates are being made to the following sections of the Prospectus:

- Directory/Management
- Index Tracking Funds, to add synthetic replication language.


