The distribution is 0.1252% franked at a franking rate of 33.2123%. The foreign income percentage is 57.1975% at a foreign tax credit rate of 24.2112% (i.e. each unit will receive 0.0290 cents worth of franking credits, 8.5054 cents worth of foreign income tax offsets and 0.0002 cents worth of foreign capital tax offsets).
