The distribution is 5.6283% franked at a franking rate of 35.9542%. The foreign income percentage is 93.2924% at a foreign tax credit rate of 15.6461% (i.e. each unit will receive 0.4441 cents worth of franking credits and 2.4323 cents worth of foreign income tax offsets).

This distribution relates to the trust’s year of income ending 30 June 2019. For the purpose of Section 12-405 of Schedule 1 of the TAA 1953, the “Fund Payment” portion of the distribution is calculated as the sum of the following components:

- Australian Sourced Income – Other Income
- Capital Gains Taxable Australian Property
  - Discounted – multiplied by 2
  - Indexation method
  - Other method
