## 2023 Year-End Gift Season

### Resource that Summarizes Key Target Dates

## Gift Receipt Deadline Dates

**Charitable Gift Annuities** State Street Global Advisors must receive all 2023 gift information and funding assets by Monday, December 4, 2023 in order for annuitants to receive a year-end payment. Gifts received after this date will have the pro-rata distribution included in the first regularly scheduled payment in 2024.

**Pooled Income Funds** State Street Global Advisors must receive all 2023 gift information and gift assets by Tuesday, December 26, 2023 to process fourth quarter beneficiary distributions.

**Charitable Remainder Trusts** State Street Global Advisors must receive all information and gift assets for newly funded trusts and additions to existing trusts to ensure timely 2023 payments, as follows: Monday, December 4, 2023 for all new trusts; and Tuesday, December 26, 2023 for additional gifts to existing trusts.

# Tax Reporting Target Dates

**Charitable Gift Annuities** Form 1099-Rs will be mailed to annuitants by Friday, January 26, 2024. Each client will receive a password protected file of completed 1099-Rs via secure email.

**Pooled Income Funds / Charitable Remainder Trusts** Schedule K-1s should be mailed to beneficiaries during the week of March 11, 2024. Copies will be provided as requested.

To meet these target dates, State Street Global Advisors must receive all new gift assets and complete gift packages — including donor and beneficiary data and cost basis/acquisition date of gift property — by Friday, December 15, 2023. Any information received after that date could result in a delay of the production of tax documents. For conversion trusts, State Street Global Advisors will need all outstanding data by Monday, November 27, 2023 to meet these target dates.

### Direct Deposit Transfers/Gifts Funded with Mutual Funds

All direct deposit information must be received 11 business days prior to the scheduled payment release date to ensure proper processing time.

Please be advised that gifts funded with mutual funds may take up to six weeks to transfer, depending on the mutual fund company. Donors and clients should keep this in mind when gifting mutual funds at year-end.
