State Street Global High Yield Bond Screened Index Fund ("Fund")

a sub-fund of **State Street Global Advisors Luxembourg SICAV**

State Street Global High Yield Bond Screened Index Fund is authorised in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier (CSSF).

What is this product?

Type

This Fund is an open-ended public limited company (société anonyme) with variable capital (société d'investissement à capital variable or SICAV).

Term

The Company is an open-ended public limited company incorporated for an unlimited period. However, it may be dissolved at any time by a resolution passed at a general meeting of Shareholders adopted in compliance with applicable laws.

This Fund has no maturity date. However, it may be terminated and liquidated by the decision of the Board under specific conditions set forth in the Prospectus.

Objectives

Investment objective The objective of the Fund is to track the performance of the fixed rate global high yield corporate bond market.

The Fund is an index tracking fund (also known as a passively managed fund).

Investment policies The investment policy of the Fund is to track the performance of the ICE BofA Global High Yield Constrained Index (or any other index determined by the Directors from time to time to track substantially the same market as the Index) as closely as possible, seeking to minimise as far as possible the tracking difference between the Fund's performance and that of the Index while screening out securities based on an assessment of their adherence to the ESG criteria i.e. international norms in relation to environmental protection, human rights, labour standards, anti-corruption and controversial weapons.

The Index measures the performance of the investment grade corporate debt publicly issued in the major domestic or eurobond markets. The Index limits issuer exposure to a maximum of 2% and redistributes the excess market value Index-wide on a pro-rata basis. To be included in the Index, securities must have a below investment grade rating, at least 18 months to final maturity at the time of issuance, at least one year remaining term to final maturity as of the rebalancing date, a fixed coupon schedule and meet any other criteria as defined in the index methodology. The Investment Manager, on behalf of the Fund, will invest using the Stratified Sampling Strategy as further described in the "Investment Techniques" section of the Prospectus, primarily in the securities of the Index, at all times in accordance with the investment restrictions set forth in the Prospectus. The Investment Manager employs a negative and norms-based ESG screen prior to the construction of the portfolio of the Fund and on an ongoing basis, as further described in the "ESG Screening" subsection of the "ESG Investing" section of the Prospectus. The Investment Manager also may, in exceptional circumstances, invest in securities not included in the Index that it believes closely reflect the risk and distribution characteristics of securities of the Index.

This EUR Hedged Class is made available to reduce exchange rate fluctuations between the currency of this Share Class and the currency in which the underlying assets of the Fund are denominated. The Share Class will be hedged back to EUR and consequently should more closely track the corresponding hedged version of the Index (ICE BofA Global High Yield Constrained Index).

In order to achieve its investment objective, this Fund will only invest in:

- Government and government-related bonds, corporate bonds, assetbacked securities, mortgage-backed securities, commercial mortgagebacked securities, covered bonds, collateralised bonds. The Fund may invest in China bonds acquired on the CIBM through the CIBM Direct Access Programme;
- Other funds;
- Liquid assets; and
- Derivatives for efficient portfolio management, limited to forward foreign exchange contracts, futures, options and swaps.

The Fund may lend up to 70% of the securities it owns.

The Shares of the EUR Class are issued in Euro.

Shareholders may redeem shares on any Luxembourg and UK business day (other than days on which relevant financial markets are closed for business and/or the day preceding any such day provided that a list of such closed market days will be published for the Fund on www.ssga.com); and any other day at the Directors' discretion (acting reasonably) provided Shareholders are notified in advance of any such days.

Any income earned by the Fund will be retained and reflected in an increase in the value of the shares.

Intended retail investor

This Fund is intended for investors who plan to stay invested for at least 3 years and are prepared to take on a medium-high level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

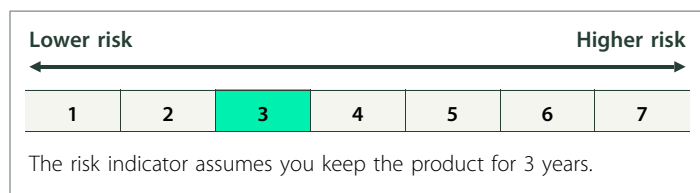

What are the risks and what could I get in return?

Risks



The risk category above shows how likely the fund is to lose money because of movements in the markets or because we are not able to pay you. The Fund's risk category is not guaranteed and may change in the future.

Performance scenarios

The figures shown include all the costs of the Fund other than the costs that you may need to pay to your advisor, distributor or other intermediary. The figures do not take into account your personal tax situation, which may also affect your return.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

Unfavourable: this type of scenario occurred for an investment between September 2019 and September 2022.

Moderate: this type of scenario occurred for an investment between March 2018 and March 2021.

What happens if the Fund Manager is unable to pay out?

The Manager is responsible for administration and management of the Company, and does not typically hold assets of the Company (assets that can be held by a depositary are, in line with applicable regulations, held with a depositary in its custody network). The Manager, as the manufacturer of this product has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the Company or the depositary is unable to pay out.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the Fund. The amounts shown here are illustrations based on a specific investment amount, taking into consideration different holding periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 3.6% before costs and 2.4% after costs.

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

This Fund is designed for medium to longer term investments; you should be prepared to stay invested for at least 3 years. However, you can redeem your investment without penalty at any time during this period, or hold the investment longer. Redemptions are possible on every working day; it will take 2 business days for you to be paid. The price for the day, reflecting the actual value of the Fund, is set each day at noon, and published on our website www.ssga.com.
