## What is this product?

### Type

This Fund is an open-ended public limited company (société anonyme) with variable capital (société d'investissement à capital variable or SICAV).

### Term

The Company is an open-ended public limited company incorporated for an unlimited period. However, it may be dissolved at any time by a resolution passed at a general meeting of Shareholders adopted in compliance with applicable laws.

This Fund has no maturity date. However, it may be terminated and liquidated by the decision of the Board under specific conditions set forth in the Prospectus.

### Objectives

**Investment objective** The objective of the Fund is to generate capital growth over the long term through investment in global equity securities.

**Investment policies** The investment policy of the Fund is to invest in companies which exhibit lower carbon emissions in the way of current emissions and future emissions (measured by fossil fuel reserves), produce green revenues, and are better positioned for the physical risks posed by climate change while screening out securities based on an assessment of their adherence to international norms in relation to environmental protection, human rights, labour standards, anti-corruption and controversial weapons.

The Investment Manager and/or Sub-Investment Manager, on behalf of the Fund, will invest actively using the Sustainable Climate Equity Strategy as further described in the "Investment Strategies" section of the Prospectus.

The performance of the Fund will be measured against the MSCI World Index.

This GBP Hedged Class is made available to reduce exchange rate fluctuations between the currency of this Share Class and the currency in which the underlying assets of the Fund are denominated. The Share Class will be hedged back to GBP and consequently should more closely track the corresponding hedged version of the Index (MSCI World Index).

The securities in the portfolio are selected primarily from the securities in the index. Non-index securities may be held in the portfolio. The

investment strategy uses defined risk parameters that mean the fund's weighting to countries, sectors and securities relative to the respective index will be limited. This is likely to limit the extent to which the Fund can outperform the MSCI World Index.

In order to achieve its investment objective, this Fund will only invest in:

- Equities and equity-related securities;
- Other funds;
- Liquid assets; and
- Derivatives for efficient portfolio management and investment purposes, limited to swaps, options, futures and forward foreign exchange contracts.

The Shares of the GBP Class are issued in Pound Sterling.

Shareholders may redeem shares on any Business Day (other than the day preceding any day on which an exchange or market on which a substantial portion of the relevant Fund's investments is traded is closed, provided that a list of such closed market days will be published for the Fund on [www.ssga.com](http://www.ssga.com)); and any other day at the Directors' discretion (acting reasonably) provided Shareholders are notified in advance of any such days.

Any income earned by the Fund will be paid to shareholders in respect of the shares.

### Intended retail investor

This Fund is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a medium-high level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

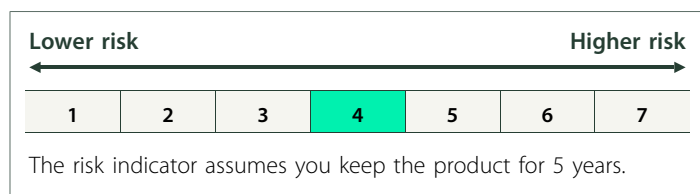

## What are the risks and what could I get in return?

### Risks



The risk category above shows how likely the fund is to lose money because of movements in the markets or because we are not able to pay you. The Fund's risk category is not guaranteed and may change in the future.

### Performance scenarios

## What happens if the Fund Manager is unable to pay out?

The Manager is responsible for administration and management of the Company, and does not typically hold assets of the Company (assets that can be held by a depositary are, in line with applicable regulations, held with a depositary in its custody network). The Manager, as the manufacturer of this product has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the Company or the depositary is unable to pay out.

## What are the costs?

### Costs over time

We have assumed:

We have classified this product as 4 out of 7, which is a medium risk category.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of State Street Global Advisors Europe Limited to pay you.

**Be aware of currency risk.** You may receive payments in a different currency, so the performance of your investment will be impacted by the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

This Fund is designed for longer term investments; you should be prepared to stay invested for at least 5 years. Redemptions are possible on every working day; it will take 2 business days for you to be paid.
