What is this product?**Type**

This Fund is an open-ended public limited company (société anonyme) with variable capital (société d'investissement à capital variable or SICAV).

Term

The Company is an open-ended public limited company incorporated for an unlimited period. However, it may be dissolved at any time by a resolution passed at a general meeting of Shareholders adopted in compliance with applicable laws.

This Fund has no maturity date. However, it may be terminated and liquidated by the decision of the Board under specific conditions set forth in the Prospectus.

Objectives

Investment objective The objective of the Fund is to track the performance of the U.S. dollar denominated emerging markets government bond market.

The Fund is an index tracking fund (also known as a passively managed fund).

Investment policies The investment policy of the Fund is to track the performance of the J.P. Morgan ESG EMBI Global Diversified Index (or any other index determined by the Directors from time to time to track substantially the same market as the Index) as closely as possible while seeking to minimize as far as possible the tracking difference between the Fund's performance and that of the Index.

The index applies an ESG scoring and screening methodology to tilt toward issuers ranked higher on ESG criteria and green bond issues, and to underweight and remove issuers that rank lower. The Index limits country exposure to a maximum of 10% and redistributes the excess market value Index-wide on a pro-rata basis. Please refer to the "ESG Best in Class Investing" sub-section of the "ESG Investing" section of the Prospectus for further details.

The Investment Manager, on behalf of the Fund, will invest using the Stratified Sampling Strategy as further described in the "Investment Techniques" section of the Prospectus, primarily in the securities of the Index, at all times in accordance with the investment restrictions set forth in the Prospectus. The Investment Manager also may, in exceptional circumstances, invest in securities not included in the Index but that it believes closely reflect the risk and distribution characteristics of securities of the Index.

In order to achieve its investment objective, this Fund will only invest in:

- Government and government-related bonds and corporate bonds from issuers in emerging markets;
- Other funds;
- Liquid assets; and
- Derivatives for efficient portfolio management, limited to forward foreign exchange contracts, futures, options and swaps.

The Fund may lend up to 70% of the securities it owns.

This CHF Hedged Class is made available to reduce exchange rate fluctuations between the currency of this Share Class and the currency in which the underlying assets of the Fund are denominated. The Share Class will be hedged back to CHF and consequently should more closely track the corresponding hedged version of the Index (J.P. Morgan EMBI Global Diversified Index).

The Shares of the CHF Class are issued in Swiss Francs.

Shareholders may redeem shares on any Business Day (other than the day preceding any day on which an exchange or market on which a substantial portion of the relevant Fund's investments is traded is closed, provided that a list of such closed market days will be published for the Fund on www.ssga.com); and any other day at the Directors' discretion (acting reasonably) provided Shareholders are notified in advance of any such days.

Any income earned by the Fund will be retained and reflected in an increase in the value of the shares.

Intended retail investor

This Fund is intended for investors who plan to stay invested for at least 3 years and are prepared to take on a medium-high level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

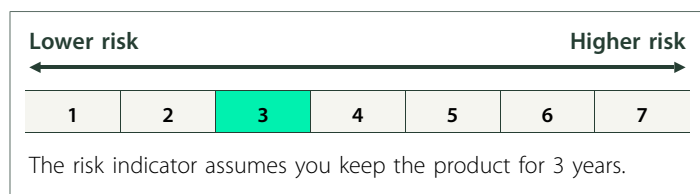

What are the risks and what could I get in return?

Risks



The risk category above shows how likely the fund is to lose money because of movements in the markets or because we are not able to pay you. The Fund's risk category is not guaranteed and may change in the future.

Performance scenarios

The figures shown include all the costs of the Fund other than the costs that you may need to pay to your advisor, distributor or other intermediary. The figures do not take into account your personal tax situation, which may also affect your return.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable: this type of scenario occurred for an investment between October 2019 and October 2022.

Moderate: this type of scenario occurred for an investment between November 2015 and November 2018.

What happens if the Fund Manager is unable to pay out?

The Manager is responsible for administration and management of the Company, and does not typically hold assets of the Company (assets that can be held by a depositary are, in line with applicable regulations, held with a depositary in its custody network). The Manager, as the manufacturer of this product has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the Company or the depositary is unable to pay out.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the Fund. We have assumed:

We have classified this product as 3 out of 7, which is a medium-low risk category.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of State Street Global Advisors Europe Limited to pay you.

Be aware of currency risk. You may receive payments in a different currency, so the performance of your investment will be impacted by the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

This Fund is designed for medium to longer term investments; you should be prepared to stay invested for at least 3 years. However, you can redeem your investment without penalty at any time during this period, or hold the investment longer. Redemptions are possible on every working day; with a payments timeline as outlined in the fund supplement.
