

Fund Objective

The Sub-Fund aims to track the FTSE® World ex UK ex Controversies ex CW, or its recognised replacement or equivalent, with 50% of the non-Sterling currency exposure hedged back to Sterling.

Investment Strategy

The Sub-Fund primarily invests at all times in the International (100% Hedged) ESG Screened Index Equity Sub-Fund and the International ESG Screened Index Equity Sub-Fund.

The following are excluded by the index provider from the index: Controversies (as defined by the ten principles of the UN Global Compact); Controversial weapons (including chemical & biological weapons, cluster munitions and anti-personnel landmines).

Any spreads disclosed are indicative only and are subject to the discretion of the investment manager, based on market conditions at the time of transaction.

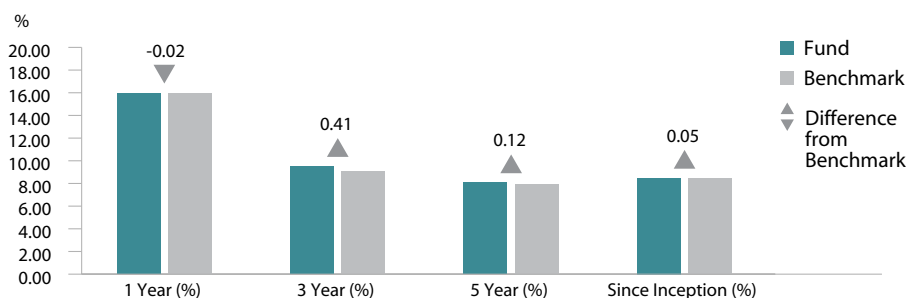

Previous to 30 June 2023, the Fund was known as International (Developed 50% Hedged) ESG Screened Index Equity Sub-Fund.

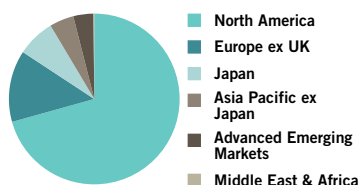
