Fund Objective

The investment objective of the Fund is to seek to provide a leveraged exposure to the UK Conventional Gilt 4.00% 2060 (the "Underlying Asset").

Investment Policy

The Fund seeks to achieve its investment objective by investing in transferable securities such as the Underlying Asset, other fixed income and money market instruments, collective investment schemes that qualify as UCITS or otherwise and by entering into transactions including but not limited to (1) Total Return Swaps ("TRS") and (2) repurchase ("Repo") transactions. Although the Fund expects to use TRS and Repos to seek to achieve a leveraged exposure to the Underlying Asset, it is possible that over time the nature of the derivatives or other transactions the Fund may use will change as market conditions change or new derivative products become available.

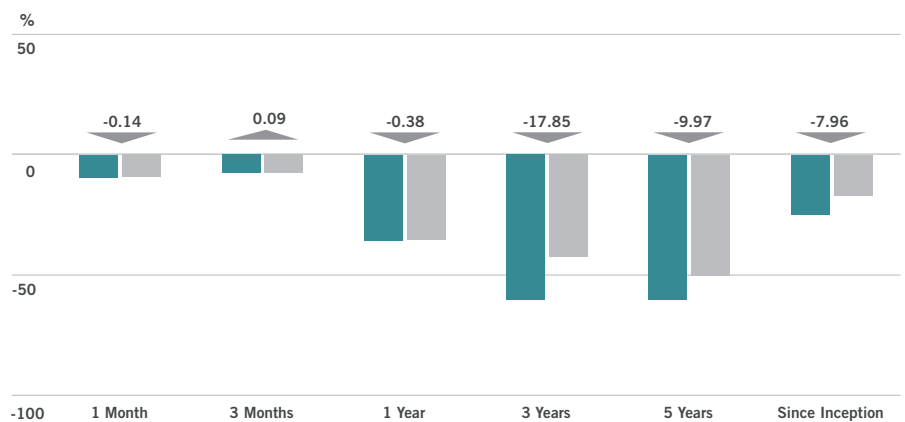
