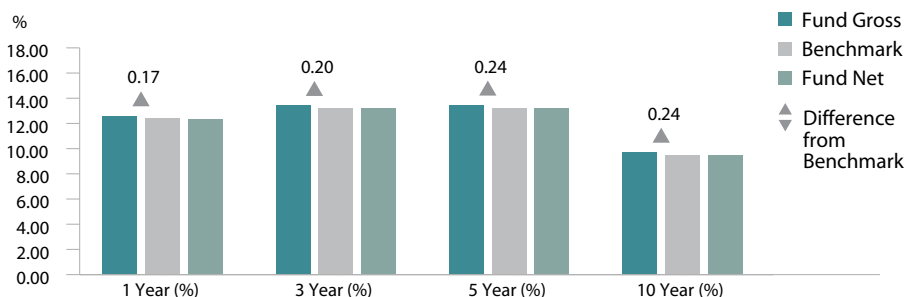

Annualised Performance

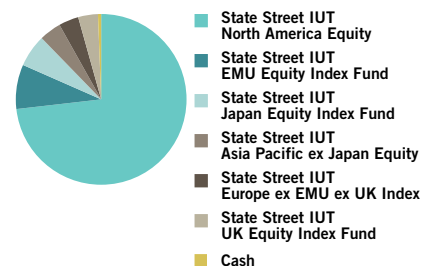

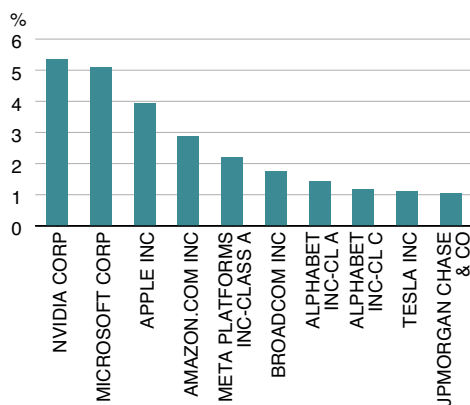
