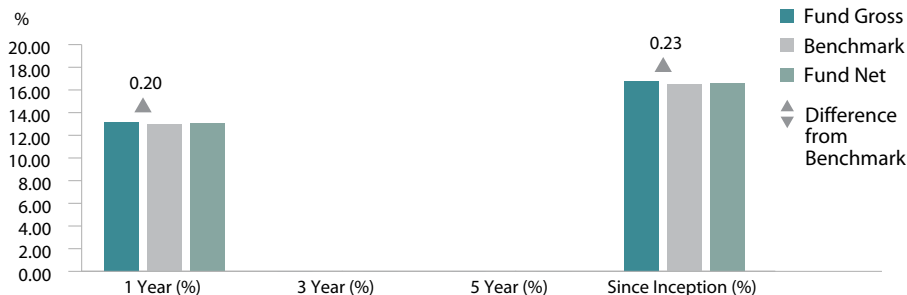

Annualised Performance

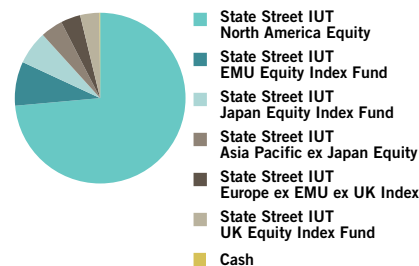

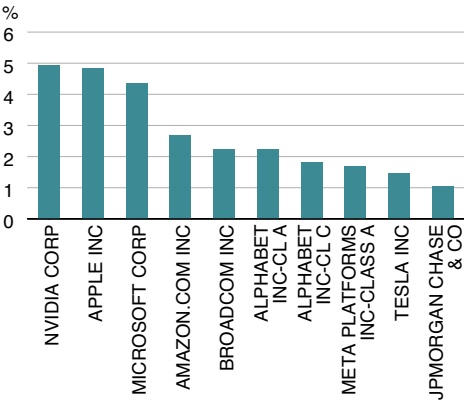
