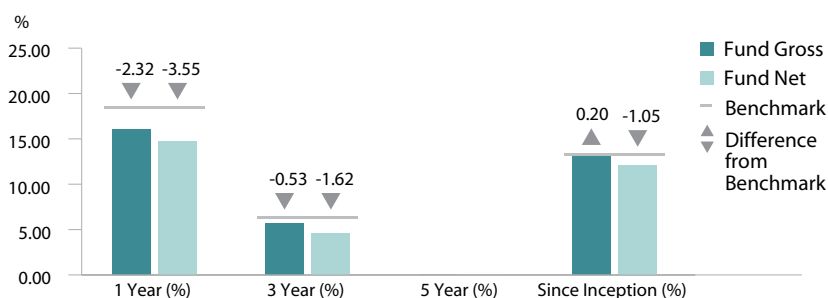

As a result, State Street Emerging Latin America Equity Fund will cease to exist and will be dissolved without going into liquidation.

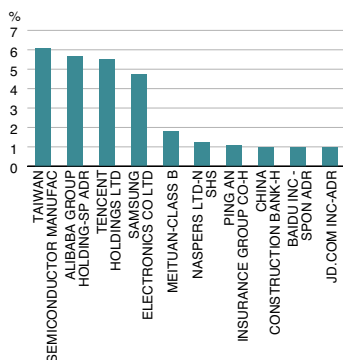

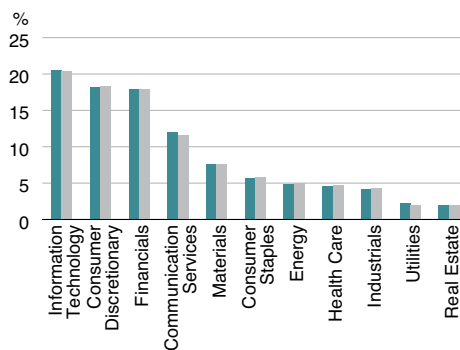

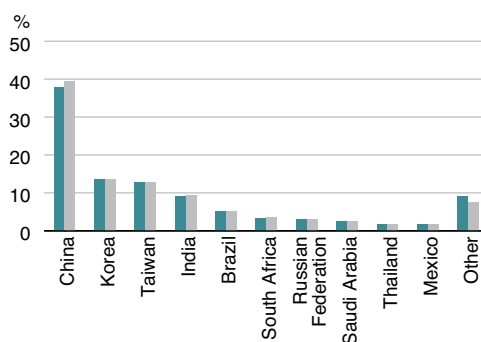
