Fund Objective

The objective of the Fund is to track the performance of the Swiss equity market.

Environmental, Social & Governance (ESG) Characteristics

The Fund promotes environmental and social characteristics but does not have as its objective sustainable investment. The Fund is categorized under Article 8 of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector ("SFDR")

Investment Strategy

The investment policy of the Fund is to track the performance of the MSCI Switzerland Screened Choice Index (or any other index determined by the Directors from time to time to track substantially the same market as the Index) as closely as possible while seeking to minimize as far as possible the tracking difference between the Fund's performance and that of the Index.

The Index measures the performance of Swiss equities. Securities are weighted by market capitalization after screening out securities based on an assessment of their adherence to ESG criteria.
