## Fund Objective

The objective of the Fund is to track the performance of the global government bond market with a maturity between 1 and 10 years.

## Investment Strategy

The investment policy of the Fund is to track the performance of the Bloomberg Global Treasury Intermediate Bond Index (or any other index determined by the Directors from time to time to track substantially the same market as the Index) as closely as possible while seeking to minimize as far as possible the tracking difference between the Fund's performance and that of the Index. The Index measures the performance of the global government bond market. Securities must be fixed rate and rated investment grade as defined by the Index methodology.
