Target Market Summary

This product is intended for use as up to a minor allocation for a consumer seeking income and capital preservation and has a medium to high risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with a medium term investment timeframe, and is unlikely to need to withdraw their money on less than one day's notice.

Investment products and diversification

To achieve its investment objective, SBSL will obtain its investment exposure to loans and other debt instruments through units in the US domiciled State Street® Blackstone Senior Loan ETF (Underlying Fund). In addition to the investment in the Underlying Fund, currency hedging is implemented using rolling one-month forward currency contracts. In pursuing its investment objective, the Underlying Fund invests at least 80% of its net assets in Senior Loans. The balance of the Underlying Fund's assets are invested in other income generating assets such as bonds, second lien loans and Collateralised Loan Obligations. In normal circumstances the capital value of the investment is expected to be more stable than growth investments, however capital losses are still possible, particularly in periods of market stress. For example, it does not detail important issues such as the potential size of a negative return (including under conditions of market stress) or that a positive return could still be less than a consumer requires to meet their investment objectives/needs. The SRM methodology may be supplemented by other risk factors. For example, some products may use leverage, derivatives or short selling, may have liquidity or withdrawal limitations, may have underlying investments with valuation risks or risks of capital loss; or otherwise may have a complex structure or increased investment risks, which should be documented together with the SRM to substantiate the product risk rating.

This consumer attribute addresses the likely period of time between the making of a request for redemption/withdrawal (or access to investment proceeds more generally) and the receipt of proceeds from this request under ordinary circumstances. Issuers should consider both the frequency for accepting the request and the length of time to accept, process and distribute the proceeds of such a request. To the extent that the liquidity of the underlying investments or possible liquidity constraints (e.g. ability to stagger or delay redemptions) could impact this, this is to be taken into consideration in aligning the product to the consumer's need to access capital. Where a product is held on investment platforms, distributors also need to factor in the length of time platforms take to process requests for redemption for underlying investments. Where access to investment proceeds from the product is likely to occur through a secondary market, the liquidity of the market for the

Distributor Reporting	
Significant dealings	Section 994F(6) of the Act requires distributors to notify the issuer if they become aware of a significant dealing in the product that is not consistent with the TMD. Neither the Act nor ASIC defines when a dealing is 'significant' and distributors have discretion to apply its ordinary meaning. The issuer will rely on notifications of significant dealings to monitor and review the product, this TMD, and its distribution strategy, and to meet its own obligation to report significant dealings to ASIC. Dealings outside this TMD may be significant because: - they represent a material proportion of the overall distribution conduct carried out by the distributor in relation to the product, or - they constitute an individual transaction which has resulted in, or will or is likely to result in, significant detriment to the consumer (or class of consumer). In each case, the distributor should have regard to: - the nature and risk profile of the product (which may be indicated by the product's risk rating or withdrawal timeframes), - the actual or potential harm to a consumer (which may be indicated by the value of the consumer's investment, their intended product use or their ability to bear loss), and - the nature and extent of the inconsistency of distribution with the TMD (which may be indicated by the number of red and/or amber ratings attributed to the consumer). Objectively, a distributor may consider a dealing (or group of dealings) outside the TMD to be significant if: - it constitutes more than half of the distributor's total retail product distribution conduct in relation to the product over the quarter, - the consumer's intended product use is <i>solution/standalone</i>, - the consumer's intended product use is <i>core component</i> or higher and the consumer's risk/return profile is <i>low</i>, or - the relevant product has a green rating for consumers seeking <i>extremely high</i> risk/return.
