1. Legal basis and distribution in Austria

This document is issued in accordance with Article 92 of the UCITS Directive (2009/65/EC), as amended by Directive (EU) 2019/1160 on the cross-border distribution of collective investment undertakings (the “CBDF Directive”), and relevant provisions of the Austrian Investment Fund Act 2011 (Investmentfondsgesetz – InvFG 2011). The shares of the Company have been notified for marketing in Austria to the Financial Market Authority (Finanzmarktaufsicht – FMA).
