

State Street® Short Duration IG Public & Private Credit ETF



Highlights
September 2026

- The State Street® Short Duration IG Public & Private Credit ETF (PRSD) is an actively managed short-term bond strategy seeking to maximize risk-adjusted returns alongside current income, by primarily allocating to investment-grade debt securities—including both public and private credit instruments.
- PRSD is managed by the State Street Active Fixed Income Team, and the portfolio managers use a risk-aware, macroeconomic top-down approach, combined with bottom-up security selection, to construct a portfolio that seeks to overweight the most attractive sectors and issuers.
- PRSD may invest in private credit instruments sourced by Apollo Global Securities LLC; private credit will generally range between 10–35% of the Fund’s portfolio.
- PRSD has outperformed 91% of its peers since inception, while registering a top decile volatility (5th percentile), max drawdown (5th percentile), Information Ratio (1st percentile), and Sharpe Ratio (10th percentile).¹

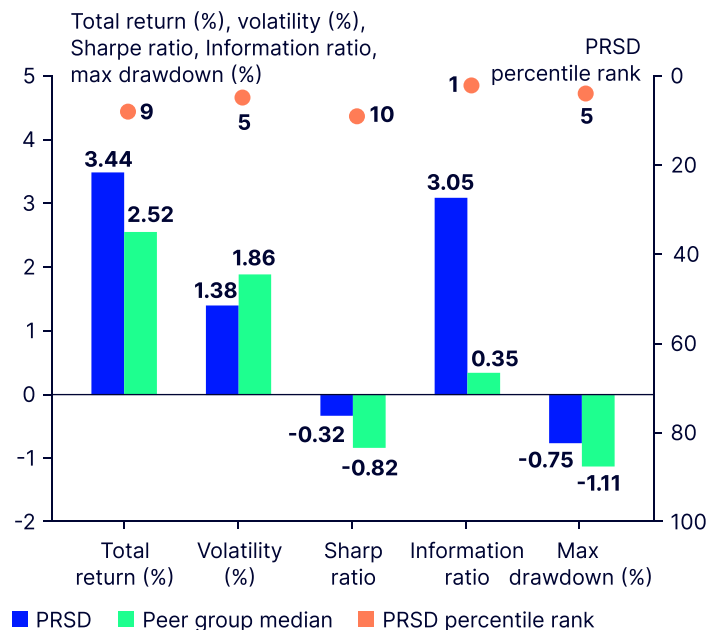

A differentiated short-duration approach for alpha generation

PRSD is an actively managed short-duration bond strategy integrating investment-grade public and private credit exposures within a short-term risk framework. Rather than relying on lower-quality credit or significant duration extension to generate excess return, PRSD seeks to enhance risk-adjusted outcomes through active sector allocation, security selection, and a potential unique source of alpha (e.g., investment-grade private credit).

A design intended to help provide access to a broader opportunity set for employing issuer and sector selection, while seeking to diversify sources of potential high quality income and return. One year after launch, and amid a complex macro backdrop that featured both drawdowns (e.g., geopolitical shocks) and rallies (e.g., monetary easing impulses), this design framework has produced strong results, as PRSD has:

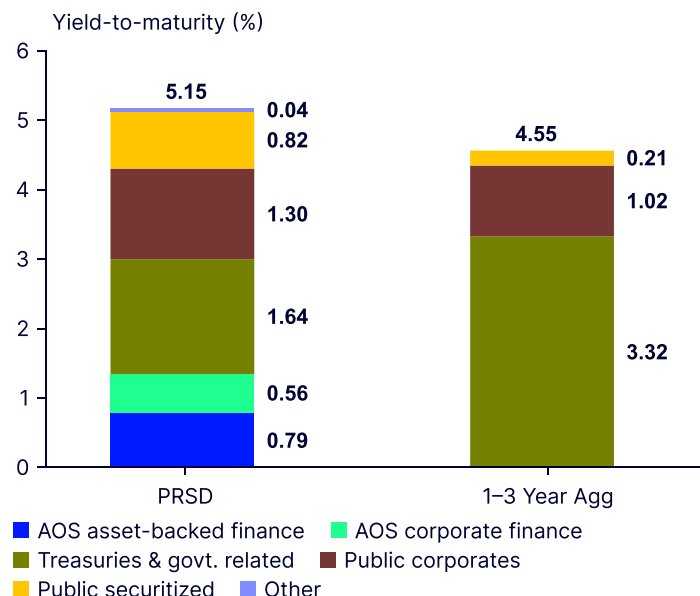
Figure 1: PRSD's absolute and risk-adjusted performance relative to peers

- Outperformed its benchmark, the Bloomberg US Aggregate 1–3 Year Bond Index, by 96 basis points (cumulative) and currently provides a pickup in yield of 60 bps (5.15% vs. 4.55%)²
- Registered top 9th percentile absolute returns (3.44%) with lower volatility and lesser max drawdown than 95% of peers, within the Morningstar Short-Term Bond category³
- Produced a risk-adjusted return, based on Sharpe Ratio, that sits in the top 10th percentile within its peer group⁴
- Delivered high performing excess returns without taking on significant excess volatility, as PRSD's Information Ratio (3.05) sits in the top percentile⁵

Figure 1 illustrates these metrics versus peers. And the strong absolute and risk adjusted performance, specifically the elevated Information Ratio, highlights the strategy's ability to employ unique, differentiated credit exposures as a source of excess returns with a high degree of consistency and without taking outsized risks.

As the portfolio blends investment-grade public credit with select private credit exposures, the sources of income significantly differ than those found in short-term bond exposures. As shown in figure 2, the sources of yield rely more on investment-grade public and private corporate bonds, as well as securitized assets, and less on Treasuries compared to the 1–3 Year Agg.

Meanwhile, the return drivers are less correlated and sensitive to below investment grade trends typically relied on by short-term bond managers to derive alpha. For example, given the unique nature of PRSD's source of alpha generation, the correlation of excess returns to its benchmark have a low correlation to other

short-term bond managers excess returns. PRSD's average correlation of excess returns against those of the largest 5 active short-term bond ETFs is 0.23 compared with an average pairwise excess-return correlation of 0.57 for those top 5 ETFs.⁶ The lesser excess return correlation metric helps illustrate the potential benefit of adding PRSD to a broader asset allocation mix as a differentiated short-duration solution that can help diversify sources of income and return.

PRSD is managed by State Street Investment Management, leveraging its expertise in ETF implementation, portfolio construction, and risk management. The team's proprietary long-term structural and intermediate-term cyclical views help support the portfolio construction process related to sector allocations, credit rating exposure, and rate sensitivity.

The team develops those views by analyzing macroeconomic factors, financial conditions, and industry and sector trends. Additionally, the team conducts rigorous fundamental and issuer-specific relative value research before including a security in the portfolio.

Private credit exposure is mainly sourced through Apollo's private credit platform, one of the most established and scaled private credit investors globally with \$834 billion in credit AUM.⁷

Apollo's scale and depth of experience across investment-grade private credit markets enable access to a diverse selection of exposures, driven by Apollo's credit business and broader origination ecosystem spanning 16 standalone platforms.

Access to private credit helps PRSD seek out potentially high-quality opportunities typically unavailable in traditional public fixed income portfolios, supporting the strategy's objective of generating differentiated outcomes while remaining anchored within a short-term risk profile.
