## **Transaction Summary**

In November 2023, Apollo-managed affiliated entities, funds and clients completed a €1.5 billion strategic investment into an Air France-KLM operating affiliate holding the trademark and most of the commercial partners contracts related to Air France and KLM's joint loyalty program (Flying Blue).

Flying Blue is one of Europe's largest and fastest-growing airline loyalty programs, serving more than 22 million members across 120 countries. The program operates a global network of over 100 commercial partners and offers a robust platform for customer engagement, with co-branded card partnerships across major financial institutions and travel providers.

Apollo invested in a platform company that holds the core Flying Blue intellectual property, contractual rights, and commercial relationships. Air France and KLM entered into long-term agreements to support the program and will continue to manage mile issuance and redemptions. The structure includes substantial reserve mechanisms and governance protections for investors. Cash flows are supported by recurring payments from AF-KLM and third-party partners, helping to ensure stability under a range of market conditions.
