**Settlement**

Contribution and redemptions shall settle on Dealing Date plus 2 working days.  
The exception to this is the As-Of Funds that shall settle on Dealing Date plus 4 working days.  
Late receipt or early settlement of monies may be subject to an interest charge.

**Notification Deadline**

Please note that instructions to invest/disinvest must be received by 10:00 am one business day prior to the dealing date. The exception to this is the As-Of and Timewise funds where the cut off is 09:30 am one business day after dealing date.  
However, these funds are singlepriced and therefore do not have crossing-dates specified.
