What Is This Product?

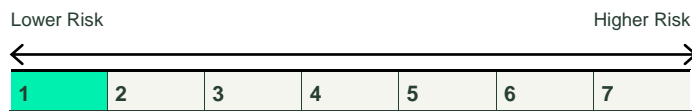
Type State Street Ireland Unit Trust is an umbrella unit trust with segregated liability between sub-funds, authorised by the Central Bank of Ireland pursuant to the provisions of the Unit Trust Act 1990.

Objectives The Sub-Fund invests substantially all of its assets into the State Street EUR Liquidity LVNAV Fund (the "Master Fund"). The investment objective of the Master Fund is to maintain a high level of liquidity, preserve capital and provide a return in line with Euro money market rates. The Master Fund is a sub-fund of the State Street Liquidity plc, and is a money market UCITS Fund. The Master Fund may invest in government securities, securities issued or guaranteed by supranational organisations; certificates of deposit; commercial paper; notes (including

floating rate and medium term notes) and bonds (fixed or floating rate) issued by corporate issuers; and asset backed commercial paper. In addition, the Master Fund may invest in any other money market instrument which is a transferable security that the Investment Manager deems to be of comparable credit quality and consistent with the Master Fund's investment objectives and which falls within the categories specified in article 9 of the MMF Regulation.

Intended Retail Investor This product is intended for investors who are prepared to take on a medium level of risk or loss to their original capital in order to get a higher potential return, and who plan to stay invested for at least one year. It is designed to form part of a portfolio of investments.

What Are the Risks and What Could I Get in Return?



The risk indicator assumes you keep the product for at least 1 year. The actual risk can vary significantly if you cash in at an early stage and you may get back less than you invested.

Risk Indicator The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class.

Costs Over Time
