What is this product?

Type

The Fund is a unit trust established on 17 August 1981 and authorised by the Central Bank of Ireland as a qualifying investor alternative investment fund on 31 March 2015.

Term

The Trust is an open ended unit trust incorporated for an unlimited period. However, it may be dissolved at any time by a resolution passed at a general meeting of Unitholders adopted in compliance with applicable laws.

This Fund has no maturity date. However, it may be terminated and liquidated by the decision of the Board under specific conditions set forth in the Prospectus.

Objectives

Investment objective The objective of the Fund is to seek to generate capital and income returns through investment in any part of the world at the discretion of the Investment Manager in Property and Property Related Investments. The Fund primarily invests in commercial property, including offices, retail, industrial and mixed use assets in Ireland, the UK and Europe. The Fund may invest in forward foreign exchange contracts in order to hedge any currency exposure.

Investment policies The Fund may utilize leverage up to a maximum ratio of 2:1 of Net Asset Value.

The Fund's shares are issued in Euro.

Units of the Fund may be redeemed on the first business day of January, April, July and October.

Distribution Policy Any income earned by the Fund will be paid to unitholders in respect of the units or retained and reflected in an increase in the value of the units, at unitholder discretion.

Intended retail investor

This Fund is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a medium-high level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

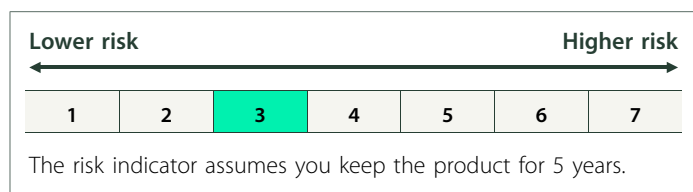

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk category.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of State Street Global Advisors Europe Limited to pay you.

Performance scenarios

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable: this type of scenario occurred for an investment between September 2020 and February 2024.

Moderate: this type of scenario occurred for an investment between May 2016 and May 2021.

Favourable: this type of scenario occurred for an investment between February 2014 and February 2019.

What happens if the Fund Manager is unable to pay out?

The Manager is responsible for administration and management of the Company, and does not typically hold assets of the Company (assets that can be held by a depositary are, in line with applicable regulations, held with a depositary in its custody network). The Manager, as the manufacturer of this product has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the Company or the depositary is unable to pay out.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the Fund. The amounts shown here are illustrations based on a specific investment amount, taking into consideration different holding periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This Fund is designed for longer term investments; you should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty at any time during this period or hold the investment longer. Redemptions are possible on a quarterly basis; it will take up to one year for you to be paid. The price for the day, reflecting the actual value of the Fund, is set each day at noon, and published on our website www.ssga.com
