## **Transaction Costs Disclosure: Unlisted Funds**

In accordance with our obligations under ASIC's Regulatory Guide 97: Disclosing fees and costs on PDSs and periodic statements ("RG97"), State Street Global Advisors, Australia Services Limited, the issuer of the funds listed below, has undertaken calculations to estimate the Fund's total transaction costs and the buy/sell spread recovery for the year ended 30 June 2019. These disclosures aim to provide investors with more transparency over the total costs of investing and they do not reduce the published net of fees return or mean investors pay any additional management fees.

Transactional and operational costs, which must be disclosed under RG97, include brokerage, clearing costs, stamp duty, bid/ask spreads of trading securities, the buy and sell spreads and transactional costs of any underlying fund and the costs of (or transactional and operational costs associated with) derivatives. Product issuers have the discretion to determine the most appropriate and reasonable way to estimate implicit transaction costs having regard to the type of asset and strategy of the Fund.
